

## 2009 and 2010 BIRTH AND FERTILITY RATES IN THE RESIDENT POPULATION

■ Data for 2009 and 2010 provide confirmation that a cyclical downturn in the birth rate is in progress: there were 568,857 births in 2009, and 561,944 in 2010, a fall of around 15,000 in two years. The slow but steady rise in the birth rate, which began in 1995, the year which saw an all-time low in the number of births (526,064), appears to have been interrupted.

■ This decline in births can be attributed to the decrease in the number of births to parents who are both Italian (a fall of 25,000 in two years); in contrast, the number of births to parents of whom at least one is foreign continues to rise, albeit at a slower pace: on average 5,000 more births in 2009 and 2010, half the increase recorded in 2008.

■ Births to parents who are both foreign exceeded 77,000 in 2009 e 78,000 in 2010, slightly less than 14% of total births. Added to the number of births to mixed couples, the figure reaches 102,000 babies born to at least one foreign parent in 2009 and 107,000 in 2010 (respectively 18% and 19% of the total).

■ With regard to the citizenship of foreign mothers, Romanian women rank first in terms of numbers of children born in Italy (16,727 in 2009), with Moroccan women second (14,370), third Albanians (9,937), and fourth Chinese mothers (just over 5,000 births).

■ Women are becoming mothers at an ever later age: over 6% of newborns have a mother aged at least 40, while the number of children born to mothers aged under 25 continues to decline (11.1% of the total).

■ The number of births outside marriage continues to increase: over 134,000 children were born to unmarried parents in 2010 (a national average of 23.6%). In the Centre-North, in particular, around 1 in 4 babies were born to unmarried parents, nearing 30% in many regions.

■ The slow yet steady rise in the average number of children per woman which began in the mid-nineties (1995 was the minimum year for fertility with 1.19 children per woman) has come to a halt during the last two years. According to the latest estimates, women who are resident in Italy have 1.41 children on average (1.31 children for women with Italian citizenship and 2.23 for foreign women).




FIGURE 1. ITALIAN AND FOREIGN BIRTHS IN RESIDENT POPULATION IN ITALY. 1995-2010, absolute values





FIGURE 3. FERTILITY RATES AND CONTRIBUTIONS BY CITIZENSHIP AND BY AGE OF MOTHER, ITALY 2009, values per 1,000 women

### Glossary

**Population register**: the continuous system for recording resident population. It is continuously updated by recording births to parents who are resident in the municipality, deregistrations due to death of residents and registrations/deregistrations due to change of residence to/from another municipality or to/from a foreign country.

**Citizenship:** the bond of membership of a state, required and documented in order to enjoy rights and be subject to specific duties.

**Resident foreign citizen**: a person with foreign citizenship or stateless person recorded in the population register.

Average age at birth: the age at the time of birth, expressed in years and tenths of years.

**Births outside marriage**: an estimate obtained by considering the total number of births for which the marital status of both parents is known and subtracting from this amount the total number of births to parents who are both married.

Births to mixed couples births of Italian citizenship with one Italian parent and the other of foreign citizenship.

Foreign births: births with both parents of foreign citizenship recorded in the population register.

Births to at least one foreign parent: total of foreign births plus total of births to mixed couples.

**Average number of children per woman** (or total fertility rate – TFT): the sum of specific fertility quotients calculated by the ratio of the number of live births to the average annual female population total, for each fertile age (15-50).

**Resident population**: people with usual place of resident in a municipality, even if on the date in question they are absent because they are temporarily in another municipality or abroad.

**Marital status**: the condition of each citizen in relation to marriage. Single: a male or female citizen who has never been married. Married: a married citizen who has not obtained the dissolution or termination of the civil effects of the marriage. Divorced: a married citizen who has obtained the dissolution or termination of the civil effects of the marriage. Widow/Widower: a citizen whose marriage has ended due to the death of her/his partner.



**Absolute change**: the difference between the total of a phenomenon at the end of the period under consideration and the total at the beginning.

Percentage change: ratio between absolute change and initial amount. It is then multiplied by 100.

Average annual percentage change (or average annual rate of change): obtained by dividing the percentage change, referring to a multi-year time interval, by the number of years in the interval.

### Methodological note

The individual survey of births recorded in the population register (Istat P.4 form) was implemented by Istat starting from January 1999 and makes it possible to obtain information at the local municipal level (and by census area) on live births in resident population, according to the following variables: sex of the newborn, date of birth (of the child), place of birth, citizenship (of the child), mother's (individual years of) age and cohort, father's (individual years of age) and cohort, mother's marital status, father's marital status, mother's citizenship and father's citizenship. These data thus allow birthrate and fertility trends to be monitored and developments in the phenomenon in relation to the main demographic characteristics of parents to be analysed.

The level of coverage, in each year, of the survey of single births recorded in the municipal population registers is evaluated in relation to the information collected by Istat through the annual municipal summary forms indicating the movement and calculation of the overall resident population and the foreign population alone (respectively Istat P.2 and Istat P.3), is respectively 99% for total resident births and 98% for births of foreign citizenship alone.
