## **Export of Italian regions**

January-March 2014

Istat presents the breakdown of national exports by Italian Regions<sup>1</sup> for the reference period January- March 2014.

In the first quarter 2014, compared with the previous period October – December 2013, in seasonally-adjusted terms, exports increased for *North-East* (+0.9%) and *Centre* (+1.9%), decreased for *South and Islands* (-3.5%) while are stationary for *North-West* (0.0%).

In the first quarter 2014, compared with the same period of the previous year, exports increased for *North-West* (+1.7%), *North-East* (+4.5%) and *South* (+5.6%) while decreased for *Centre* (-0.9%) and *Islands* (-16.5%).

In the same period more relevant increases, according to their contribution to total export increment, were recorded for Emilia-Romagna (+5.9%), Piemonte (+6.9%), Veneto (+2.7%), Puglia (+18.1%), while relevant decreases are recorded for Sicilia (-15,6%), Toscana (-4,6%), Sardegna (-18.1%) and Lazio (-1.2%).
