

Foreign Trade Export of Italian regions January-September 2014

Istat presents the breakdown of national exports by Italian Regions¹ for the reference period January- September 2014.

In the third quarter 2014, compared with the previous period April – June 2014, in seasonally-adjusted terms, exports increased for *North-West* (+2.3%) and *Centre* (+2.2%), decreased for *South and Islands* (-2.0%) and *North-East* (-0.4%).

In the first nine months of 2014, compared with the same period of the previous year, exports increased for² *North-West* (+1.5%), *North-East* (+3.0%), *Centre* (+2.0%) and *South* (+1.9%) while decreased for *Islands* (-13.0%).

In the same period more relevant increases, according to their contribution to total export increment, were recorded for Emilia-Romagna (+4.2%), Piemonte (+3.3%), Veneto (+2.5%), Liguria (+9.5%), Marche (+7.4%) and Puglia (+5.0%), while relevant decreases are recorded for Sicilia (-13.4%), Sardegna (-12.0%), Umbria (-3.6%) and Basilicata (-9.4%).
