

Export of Italian Regions

Fourth quarter 2015

Istat presents the breakdown of national exports by Italian Regions¹ for the reference period January-December 2015.

In the fourth quarter 2015, compared with the previous period July – September 2015, in seasonally-adjusted terms, exports increased for *South and Islands* (+2.1%), *North-East* (+2.0%), *North-West* (+1.0%) and *Centre* (+0.9%).

In the year 2015, compared with the previous year, exports increased for South (+10.2%), North-East (+4.7%), Centre (+4.0%) and North-West (+2.7%) while decreased for Islands (-7.3%).

In the same period more relevant increases, according to their contribution to total export increment, were recorded for Piemonte (+7.0%), Veneto (+5.3%), Emilia-Romagna (+4.4%), Lazio (+9.2%), Lombardia (+1.5%) and Basilicata (+145.7%), while relevant decreases are recorded for Sicilia (-12.4%) and Liguria (-4.2%).
