

Export of Italian Regions

First quarter 2016

Istat presents the breakdown of national exports by Italian Regions¹ for the reference period January-March 2016.

In the first quarter 2016, compared with the previous period October – December 2015, in seasonally-adjusted terms, exports decreased for *Centre* (-3.7%), *North-West* (-3.3%), *North-East* (-2.8%) and *South and Islands* (-1.9%) .

In the first quarter 2016, compared with the first quarter of the previous year, exports decreased for *Islands* (-20.3%), *North-West* (-2.5%), *North-East* (-0.1%), while increased for *South* (+12.2%) and *Centre* (+2.3%).

In the same period more relevant decreases, according to their contribution to total export increment, were recorded for Piemonte (-7.1%), Sardegna (-38.4%), Liguria (-12.3%), Sicilia (-8.1%), Campania (-4.7%) and Friuli-Venezia Giulia (-3.2%) while relevant increases are recorded for Basilicata (+118.6%), Abruzzo (+14.9%), Lazio (+5.5%) and Molise (+151.4%).
