

Regional Accounts

Years 2011-2013

Istat disseminates Regional (Nuts2) and Provincial (Nuts3) accounts data at current prices consistent with national estimates published in September 2014, which implement new sources, methods and the innovations of ESA2010.

In 2013, GDP per capita amounted to 33,500 euros in the North-west area, to 31,400 euros in the North-east and 29,400 euros in the Centre.

The South and Islands area, with a level of GDP per capita of 17,200 euros, reported a very large negative differential. Its level was 45.8% lower than in the Centre-North area.

The regional ranking was lead by the Autonomous Province of Bolzano/Bozen, with a GDP per capita of about 40,000 euros and registered an increase in comparison to 2011. The lowest value was recorded in Calabria with less than 16,000 euros, down from 2011.

The final consumption expenditure of households at current prices in 2013 amounted to 18,300 euros per inhabitant in the Centre-North and 12,500 euros in the South and Islands area.

Lazio and Sicilia were the regions with the greatest weight of tertiary activities, in terms of incidence of sectoral value added, while Basilicata and Emilia-Romagna were those with the highest propensity in agricultural and industrial activities.

In 2012, Milano was the province with the highest levels of value added per capita, amounting to 46,600 euros; Bolzano followed with 35,800 and Bologna with 34,400 euros.

The provinces with the lowest levels of value added per capita were Medio-Campidano and Agrigento, with about 12,000 euros, followed by Barletta-Andria-Trani and Vibo Valentia with less than 13,000 euros.

In the provinces of Milano, Roma and Trieste the contribution of financial services, real estate and professional services was prevalent. The contribution of the industrial sector ranked first in many provinces of the North-east area, and especially in Modena.

In the period from 2011 to 2013, only Lombardia and Trentino-Alto Adige reported positive employment performance, while Calabria and Molise recorded the largest fall (-8% in terms of number of workers).

Time series since 1995, at current prices and at previous year prices, will be disseminated with the next release, scheduled for September.

FIGURE 1. GDP PER CAPITA AT MARKET PRICES BY REGIONS. YEAR 2013, THOUSANDS OF EUROS





FIGURE 2. VALUE ADDED PER CAPITA AT BASIC PRICES BY PROVINCES. YEAR 2012, THOUSANDS OF EUROS
