

## Export of Italian regions

January-December 2014

Istat presents the breakdown of national exports by Italian Regions<sup>1</sup> for the reference period January-December 2014.

In the fourth quarter of 2014, compared with the previous period July–September 2014, in seasonally-adjusted terms, exports increased for *North-East* (+3.7%), *Centre* (+1.6%), *North-West* (+1.4%) and decreased for *South and Islands* (-0.3%).

In the year 2014, compared with the previous year, exports increased for<sup>2</sup> *North-East* (+3.5%), *Centre* (+3.0%), *North-West* (+2.2%), and *South* (+1.1%) while decreased for *Islands* (-13.8%).

In the same period more relevant increases, according to their contribution to total export increment, were recorded for Emilia-Romagna (+4.3%), Lombardia (+1.4%), Veneto (+2.7%), Piemonte (+3.3%) and Marche (+7.5%), while relevant decreases are recorded for Sicilia (-13.9%) and Sardegna (-13.6%).
