

Regional Accounts

Years 2014-2015

Istat disseminates Regional accounts data (Nuts2 and Nuts3) consistent with national estimates published in September 2016.

In 2015, GDP per capita amounted to 33,400 euros in the North-west area, to 32,300 euros in the North-east and 29,300 euros in the Centre. The South and Islands area, with a level of GDP per capita of 17,800 euros, reported a very large negative differential. Its level was 44.2% lower than in the Centre-North area.

The regional ranking was led by the Autonomous Province of Bolzano/Bozen, with a GDP per capita of about 41,100 euros, while the lowest value was recorded in Calabria with 16,500 euros.

The final consumption expenditure of households at current prices in 2015 amounted to 18,700 euros per capita in the Centre-North and 12,700 euros in the South and Islands area. As for the sectoral composition of value added, Lazio and Sicilia were the regions with the greatest weight of tertiary activities, while agricultural and industrial activities prevailed in Basilicata and Emilia-Romagna.

In 2014, Milano was the province with the highest level of value added per capita (around 44,800 euros); Bolzano followed with 36,400 and Bologna with 34,300 euros. The provinces with the lowest level of value added per capita were Medio Campidano, Agrigento, Barletta-Andria-Trani, Cosenza, Vibo Valentia and Siracusa, with about 13,000 euros.

In the provinces of Milano and Roma the contribution of financial services, real estate and professional services prevailed. The contribution of the industrial sector ranked first in many provinces of the North-east area, and especially in Modena and Vicenza.

In 2015 the disposable income of households per capita amounted to about 21,100 euros in the North-west (0.9% more than in 2014), 20,400 euros in the North-east (0.5% more than in 2014), 18,700 in the Centre (0.7% more than in 2014) and 13,200 euros in the South and Islands area (+1.3% over 2014).

The regional ranking was led by the Autonomous Province of Bolzano/Bozen (23,700 euros per capita), while the last region in the ranking proved to be Calabria (12,200 euros per capita). In the period from 2011 to 2015, labour input showed positive performance only in the Autonomous Province of Bolzano/Bozen, while Calabria, Molise and Friuli Venezia Giulia recorded the largest fall (from -1.6% to -1.0% in terms of number of workers).

FIGURE 1. GDP PER CAPITA AT MARKET PRICES BY REGION. Year 2015, thousands of euros

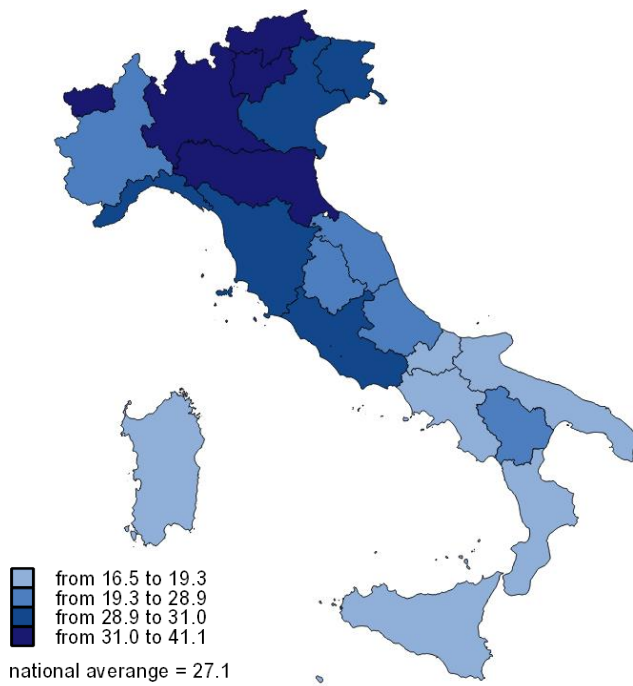
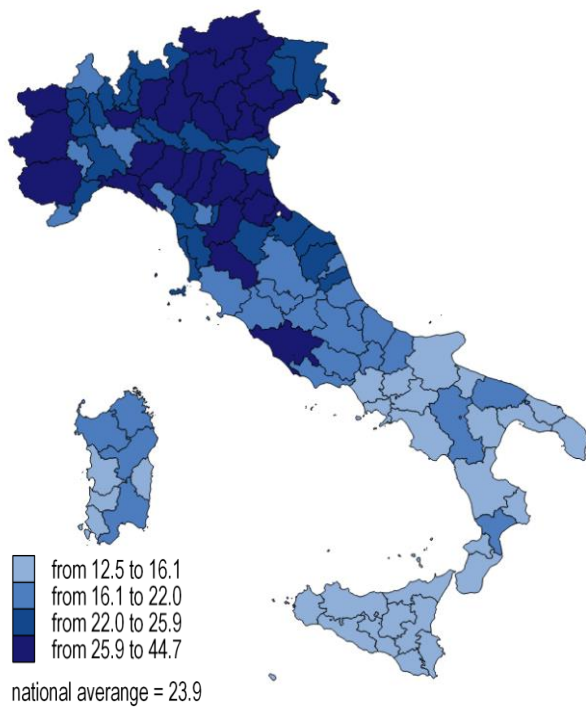


FIGURE 2. VALUE ADDED PER CAPITA AT BASIC PRICES BY PROVINCE. YEAR 2014, thousands of euros
