


PPI Data Visualization App

- Web app built utilizing R/Shiny (open-sourced publically available software)
- Developed by analysts and users
- Supplemental app to official index review system
- Emphasizes graphical representations of data to highlight decision-making opportunities
- Allows users to improve index precision and aids in workflow prioritization prior to index release



- Business modeling
- Code review and code documentation
- Testing- black/white box, SQL review, stress/load, security
- Requirements documentation
- Configuration management
- Help documentation
- Quick and defined iterations



Future steps

- Work with other Offices to incorporate the app or elements of the app into their review processes.
- Create an R package allowing users to structure their data to create similar outputs
 - Data users will be provided instructions on how to structure their data.
