Dear Sir, Dear Madam,

The month of October sees the launch of the permanent census of the population and housing, designed by Istat – National Statistics Institute.

Since 2018, the census has been organised differently than in the past: each year, groups of citizens randomly identified among families residing in the municipalities making up the statistical sample take part in it. Your name was extracted from the registry list of families residing in the municipality as at 01/01/2021.

The survey that involves your family will be held from **4 October** to **23 December 2021**.

The data we request will help us learn the main social and demographic characteristics of the population of our country, the number of houses and the distinguishing features of those actually inhabited.

Istat carries out this survey and processes the related personal data in the performance of a public interest task. The census is in fact envisaged by European Regulation No. 763/2008 and by Law No. 205/2017, and is included in the national statistical program in force (code IST-02494), which for this survey lays down its obligatory nature and penalties for its transgressors.

Information collected will be processed in compliance with the legislation on the protection of statistical secret and the protection of personal data (see the section headed “Data processing” at the back of the letter).

The full collaboration of your family is going to be essential for the survey to be successful and above all in order to enrich the existing wealth of information benefiting the community at large.

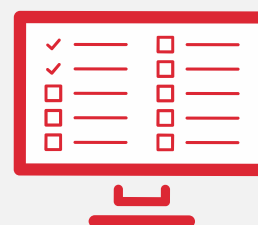

INSTRUCTIONS ON HOW TO ANSWER THE QUESTIONNAIRE

From **4 OCTOBER** to **7 NOVEMBER**, the family can fill in the questionnaire online in one of the following ways:

- by connecting to <https://raccoltadati.istat.it/questionario> and entering the credentials on the side, or, for the family head, by using his own SPID or CIE.
- by approaching the Municipal Survey Centres (CCR), active throughout the survey period, where it can use a pc with Internet access to fill out the questionnaire independently or via an interview run by a municipal operator, and ask for information and clarifications.



ACCESS CREDENTIALS

From **8 NOVEMBER** to **23 DECEMBER**, the families that have not yet completed the online questionnaire will be contacted by a municipal operator for an interview over the phone or face to face.

Until **13 DECEMBER**, the family can continue to fill in the questionnaire online using the access credentials. From **14 DECEMBER**, the interview may only be run through a municipal operator at your home or at the Municipal Survey Centres. If the appointment for the interview has already been scheduled at your home, the questionnaire must be filled in exclusively with the help of a municipal surveyor.
