

## Birth and fertility rates among the resident population: recent characteristics and trends Year 2008

Istat has published the results of a survey based on Population Register for 2008, consultable at [demo.istat.it](http://demo.istat.it), that monitors births in relation to the main demographic characteristics of parents and indicates the factors underlying changes in the birth and fertility rates among the resident population. The data, available at municipality level, also make it possible to calculate the main indicators of reproductive behaviour: Total Fertility Rate and Mean Age at childbearing. These indicators can be calculated in relation to the overall number of resident women or broken down by nationality or marital status.

In 2008, 576,659 births were registered in municipal population registers, roughly 13,000 more than the previous year (563,933 in 2007). These figures confirm the recovery that began in the second half of the 90s (after 30 years of decline): 1995 was the year of minimum in the number of births (526,064) and in the Total Fertility Rate (1.19 children per woman).

Particular attention should therefore be paid to the various structural changes that characterise the phenomenon.

Among these is the continuous increase in age of mothers at childbearing: 5.7% of newborn babies have a mother aged at least 40 (an increase from 12,383 births in 1995 to 32,578 in 2008), while there is an on-going reduction in the number of births to mothers below the age of 25 (slightly more than 64,000 in 2008 or 11.1% of total).

The percentage of births to unmarried parents has more than doubled: from 8.1% in 1995 to 19.6% in 2008 (over 102,000 births). In central and northern Italy in particular, births to unmarried parents are now almost 1 in 4.

Births to foreign couples continue to rise, reaching more than 72,000 in 2008 and equivalent to 12.6% of total births. This proportion increases to 16.7% when taking into account births to mixed-nationality couples. In overall terms, then, births to at least one foreign parent are now close to “*quota 100,000*”.

In 2008, foreign female citizens had on average 2.31 children per woman – a decline compared to recent years but still one child more than Italian women (1.32). The greater propensity to have children among foreign female citizens significantly contributes to the recovery of the overall fertility rate of the resident population: from 1.19 in 1995 to 1.42 children per woman in 2008.

Despite the different reference population (births among the resident population for 1995 and births among the resident population for 2008), and a slight difference in the classification of births (by filiation in 1995 and by civil status of the parents in 2008), the comparison between the two figures provides useful indications on the recent evolution of out-of-marriage births.
