Export of Italian regions

January-June 2013

Istat presents the breakdown of national exports by Italian Regions¹ for the reference period April- June 2013.

In the second quarter 2013, compared with the previous period January – March 2013, in seasonally-adjusted terms, exports decrease for *North-West* (-1.0%), *Centre* (-0.9%) and *South and Islands* (-3.2%) while increase for *North-East* (+3.6%).

In the first half of 2013, compared with the first semester of the previous year, exports decrease for² *North-West* (-0.2%), *South* (-6.0%) and *Islands* (-13.8%), increase for *North-East* (+0.8%) and *Centre* (+2.8%).

In the first six months of the year, compared with the first half of 2012, more relevant decreases, according to their contribution to total export growth, were recorded for Liguria (-13.4%), Puglia (-17.0%) and Sicilia (-17.9%), while relevant increase are recorded for Marche (+12.7%), Lazio (+7.9%) and Bolzano/Bozen (+5.5%).
