Export of Italian regions

January-June 2014

Istat presents the breakdown of national exports by Italian Regions¹ for the reference period January- June 2014.

In the second quarter 2014, compared with the previous period January – March 2014, in seasonally-adjusted terms, exports increased for *North-East* (+1.3%) and *Centre* (+1.3%), decreased for *South and Islands* (-2.5%) and *North-West* (-0.3%).

In the first half of 2014, compared with the same period of the previous year, exports increased for² *North-West* (+1.2%), *North-East* (+3.4%), *Centre* (+0.6%) and *South* (+2.4%) while decreased for *Islands* (-11.1%).

In the same period more relevant increases, according to their contribution to total export increment, were recorded for Emilia-Romagna (+4.5%), Piemonte (+4.4%), Veneto (+3.0%), Marche (+6,6%) and Puglia (+9.4%), while relevant decreases are recorded for Sicilia (-11,1%), Sardegna (-11.2%), Lazio (-3.1%) and Basilicata (-24,6%).
